The U.S. Visa at a Glance

The United States has a long history of welcoming immigrants from all over the world. U.S. values the contributions of immigrants, who continue to enrich this country and preserve its legacy as a land of freedom and opportunity. The United States is an open society. Unlike many countries, the United States does not impose internal controls on most visitors, such as registration with local authorities etc.

There are two broad categories of U.S. visas:

1. Immigrant visas:

For those intending to reside permanently in the United States. Generally to qualify for Legal Permanent Residency (LPR) status, commonly known in the United States as a 'Green Card', nomination is required. Nomination may be by a relative or employer and in rare cases by oneself. There are essentially two main classes you can apply under for LPR. i.e. Employer Nomination and Family Nomination. Both classes require a multi step application process.



2. Non-immigrant Visas

There are more than twenty-five general categories of non-immigrant visas. Most are targeted at a person's particular purpose in visiting the U.S. and the terms of those visas will vary according to the category.

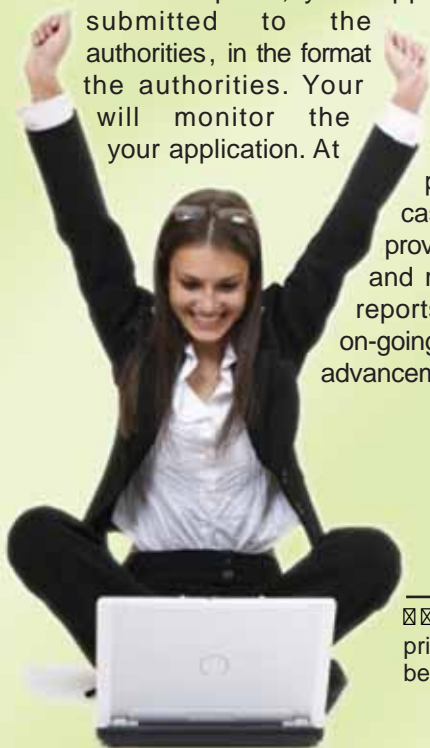
